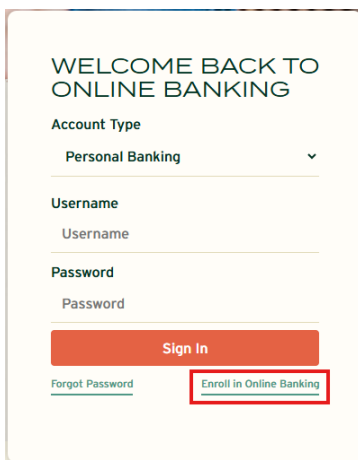

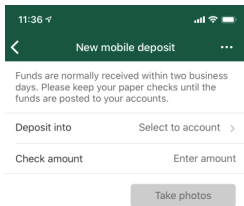

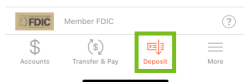

POSITIVE PAY

Positive Pay protects against check fraud by comparing each check presented for payment against your electronic check-issued file. We will notify you of any mismatches so you can either automatically return unauthorized payments or view exceptions online, and direct C&F Bank to pay or return all checks.

BENEFITS AND FEATURES

- Protection against altered and counterfeit checks: Positive Pay provides you the opportunity to return checks within the required 24 hours deadline.
- Pay or return decisions made with confidence: Images of exception are provided via Cash Manager to help you quickly and easily determine the correct disposition of checks with discrepancies.
- Funds under your control: Timely return decisions allow funds to remain in your account, avoiding delays and risk of loss associated with late returns.

ACH ALERT

To help protect your business from ACH fraud, C&F Bank offers ACH Alert, which allows you to define acceptable ACH debits to clear your business accounts. ACH Alert through C&F Bank helps protect your funds, allowing only ACH debit transactions from the parties you authorize, within the dollar limits you designate, to post to your account.

BENEFITS AND FEATURES

- **ACH Alert Filter:** When an originating company attempts to post an ACH debit to your account, our system will compare the incoming identification number (ID) to the authorized company ID that you have provided the Bank. If the ID is not on our list to pay, It will create an exception that you will decision to either pay or

return within online banking. This will allow your company to control who is authorized to electronically originate debits to your account.

- **ACH Alert Block:** This service will block all specified ACH debits from posting to your account and the Bank will automatically return electronic ACH debits to the originator. No customer intervention is necessary once the service is set up.
